Guidelines for renters in Mt. Gretna Campmeeting

Quiet Hours in Mt. Gretna Campmeeting

According to Rule #17 in our Rules & Regulations handbook, all residents within the borders of the Mt. Gretna Campmeeting are expected to maintain quiet hours all day Sunday, 10 p.m. to 7 a.m. Monday through Thursday, and 11 p.m. to 7 a.m. Friday and Saturday. In addition, quiet hours are in effect all day beginning July 15th and going through August 31st every summer for our "Quiet Season". High decibel power tools, such as saws and leaf blowers, and manual work, such as framing and roofing, are prohibited. Residents must keep the volume of television and audio systems to a decibel level not heard outside the cottage.

Driving and Biking

Reckless driving/biking and speeding within the boundaries of The Campmeeting are strictly prohibited. MGCA Members and visitors must drive only on permitted streets. When riding bicycles, roller boards, etc., in the Campmeeting, please keep your speed to walking speeds.

Parking in Mt. Gretna Campmeeting

Parking of motor vehicles shall be permitted only in designated parking areas. All streets and walk-ways are designated as fire lanes. Vehicles can be parked at the Campmeeting lots near the play-ground off of 1st street or the parking lot near the Mt. Gretna Fire hall. Vehicles parked in other areas of Campmeeting will be towed at owner's expense. Renters' vehicles should not be parked at the church parking lot as this is a private lot owned by the Mt. Gretna United Methodist Church. Cars parked there during restricted church activities will be ticketed and towed.

Outdoor grilling

Charcoal or LP gas burners and other open-flame cooking devices shall not be operated on combustible covered porches. It is recommended that they not be operated within 10 feet of combustible construction. Fire rings, fire pits (permanent or portable), chimineas, and deck/patio heaters will be permitted, but must have a properly fitting spark screen cover over the open flame and shall not be operated on combustible covered porches or within 10 feet of combustible construction. These devices must be attended when in use and fully extinguished when not attended.

Trash and Recyclables

All trash and recyclables shall be placed in proper receptacles and shall be available for collection on Mondays. Trash and/or recyclables shall be placed outside for collection no earlier than the night before collection day. Trash is collected every Monday and recycling every other Monday; please refer to www.mtgretnacampmeeting.com for recycling dates. Containers should be returned to their normal location quickly after pick-up. Excess refuse shall incur additional charges as determined by the collector. Collection is often at the front-door of the cottage, however you will need to confirm collection location with cottage owner.

Picking up after your pets

In accordance with West Cornwall Township Ordinance 2-101, pet owners must not allow their animals to litter the private property of other MGCA Members, or the Common Property such as walking paths, streets, and park facilities. All litter must be removed and disposed of promptly and properly. Dogs must be leashed when on Campmeeting property. The ordinance provides for fines of up to \$1,000 or imprisonment for a term not to exceed 90 days.
